### III. Executive Director Updates – D. Johnson

#### • General Updates

Ms. Johnson advised the Council that yesterday the Agency was made aware of a threat of property destruction via it Facebook Messenger. The decision was made not to shut down the building due to the type of threat. Travis Reed of the Port Huron Police Department was in communication with the Agency and advised that the individual had been located and apprehended within hours. The Agency is thankful to the PHPD for their speedy response to the matter. Discussion was had amongst Council members regarding the proper protocol addressing such threats.

#### IV. CMH Updates- K. Gallagher

#### • Harrison Elementary

The Agency has officially contracted .2 rooms at the former Harrison Elementary building, and is currently working on furnishing them. The goal for the space is for it to me used to expand services. The rooms will be available on Resource Scheduler starting early March, and is expected to be used mostly by Children's wrap around meetings however, will be available for all. Music and Minds classes, as well as Art classes are also slated to take place there.

### • Creative Employment Opportunities/CE River District

Ms. Gallagher reports that linking to a new day program for individuals with intellectual or developmental disabilities has been approved by the Board. Packets are being processed for Individuals interested in attending Creative Employment Opportunities as the River District Community Enterprises location will be closing due to poor attendance and deteriorating building. Community Enterprises has 2 Port Huron locations that will remain open. These programs are available to adult ID/DD populations. Discussion took place on area programs that are available to this population of individuals which help in training job skill for people interested in seeking employment
