Dear St. Clair County Community Mental Health Staff, Contract Providers, and Community Partners:

As you may be aware, the Michigan Department of Health and Human Services (MDHHS) has issued a Request for Proposals (RFP) to procure PIHP (Prepaid Inpatient Health Plan) contracts competitively. This proposal threatens the very foundation of Michigan's public mental health system. If enacted, it will lead to significant service disruption, increased administrative costs, and fewer resources available for the people and families who rely on us.

Your perspective as employees on the frontlines of care and community partners is powerful. Policy makers must hear directly from those who know firsthand what these changes would mean for the individuals living with mental illness, intellectual/developmental disabilities, and substance use disorders, and equally as important, the employees at service providers, like us, across the state.

We have developed two letter templates for you to personalize and send to your state legislators/governor and to the Director of MDHHS. Please take a few minutes to:

1. Add your personal perspective: Update the information where brackets [...] are. There is space to include your name, role, and, if you wish, a brief statement about how these changes would impact the individuals you serve or our community as a whole.
2. Send the letter promptly to the contacts you've chosen. On the following pages, you can find addresses for the Legislators serving St. Clair County.
3. Encourage your colleagues to do the same so that, collectively, our voices convey the depth of concern from those who provide services every day.
