III. EXECUTIVE DIRECTOR UPDATE -D. Johnson

• Community Health Improvement Plan

A copy of the St. Clair County Health Department's CHIP PowerPoint was provided to Council Members and a brief overview of the information was discussed. Key community issues identified in the report were: Mental/Behavioral Health, Substance Use Disorder, Obesity and Associated Health Behaviors.

• Strategic Planning

The Agency continues to work on updated Strategic Planning framework using the CHIP review and community surveys sent out by the Agency in our Annual Report to evaluate the needs of the area residents.

• Mission, Vision, Values

A draft of the outline for the updated Agency Mission, Vision, and Values was provided to Council Members for review. This draft will be a companion article to a simplified Mission, Vision, and Values statement.

IV. CMH Updates- K. Gallagher

A. Galley Updates

The future of the Galley remains unknown. Chef Mike has been on a leave of

absence following a medical issue. As a result the Home-style Cooking classes have been put on hold for the near future. The Agency is currently considering options that will allow us to continue to offer these valuable courses long term after Chef Mike's retirement in September.

B. CCBHC Site Visit

The Agency will be hosting its first CCBHC site visit next week. This is an opportunity for consultation, as we continue to operate as a demonstration site.

C. Naloxone/Fentanyl Strip Box

The Odyssey House will be providing a Naloxone Box to the Agency which will house doses to be available to the community. Additionally, in the future the Agency hopes to add Fentanyl Test strips to this service, however the Health Department is unable to supply those at this time.

D. Therapeutic Foster Care Model

A conference call too place this morning wherein the urgent need for therapeutic foster care homes in the community. The Agency continues to advocate for regulated seclusion and restraint options to be available to keep children safe in foster or group home settings. There was discussion regarding alternative plans for our area children.
