Recently, doctors diagnosed an individual receiving CMH services with multiple pulmonary embolisms and Deep Vein Thrombosis. Pulmonary embolisms are blood clots that occurs in the lungs, deep vein thrombosis is a blood clot that forms in a vein deep in the body; left untreated both can be fatal. The individual's public guardian contacted the ACT team that against medical advice the individual had left the treating hospital's Intensive Care Unit.

Kellie and Natalie immediately dropped what they were doing and went to the individual's home in an attempt to convince her to return to the Intensive Care Unit. Despite the individual's initial resistance, Kellie and Natalie's rapport with the individual, their empathy, and professionalism won the individual over. The individual returned to the hospital and once there Kellie and Natalie sat with her for several hours to show support and ensure she was positive about her decision to return for care. Kellie and Natalie's swift and effective intervention likely saved this individual's life and is indicative of the care and compassion they offer everyone with whom they work.
