SUBJECT: SCCCMH Board Appointment

St. Clair County Community Mental Health Board has seen much movement over the past year which has resulted in vacancy for District 7. Commissioner VandenBosche is requesting the appointment of Ms. Dawn Davey to fill this vacancy.

Changes that have occurred over the year are as follows:

- District 7: Ms. Lori Ames represented District 7 until a recent move that took her to District 5 as an At-Large Member. In speaking with Commissioner VandenBosche he approved the representation until such time a vacancy occurred.
- District 3: Ms. Cynthia Cutright resigned on 12/6/2022 leaving a vacancy in District 3. She previously moved out of District 2 (original appointment) into District 3 as At-Large. Ms. Jessica Totty is the representative for District 3.
- District 2: Ms. Martha Partipilo was moved from an At-Large Member for District 2 to a Commissioner appointment to District 2. This was the vacancy created by Ms. Cutright (both were appointed by Commissioner Baldwin).
